POSITION CONTEXT:

Christ Church Grammar School is an Anglican day and boarding school for boys from Pre-Kindergarten to Year 12. Located in Perth, Western Australia, the school overlooks the Swan River at Freshwater Bay in Claremont. Enrolments are comprehensive and at present are approximately 1650 including boarders. The school consists of the Preparatory School (PK to 6) and the Senior School (Year 7 to 12).

 - An interest in and commitment to the innovative use of information communications technologies in curriculum delivery, including developing online and digital learning resources
 - An ability to contribute to the co-curricular programs including a possibility of Saturday sport
