TERMS AND CONDITIONS

Confirmation: The above booking will be held for 14 days. Bookings are confirmed upon the receipt of a signed copy of this booking form and deposit payment.

Cancellation: Deposits are non-refundable. Cancellations of less than 30 days prior to the scheduled date will incur a cancellation fee of 30% of the current quote total, in addition to the deposit. If less than 14 days written notice of cancellation is given, the group will incur a cancellation fee of 50% of the current quote total, as well as the deposit amount and any cancellation fees charged to Kerem Adventure Camp by third party providers.

Guest Attendance: Final guest attendance may be provided up to 72 hours prior to arrival. Guests who do not attend camp following the final update will be charged a 15% cancellation fee of the individual fee due, as calculated by the quote. Guests who leave the camp after the first night will not be eligible for any refund.

Damages: Damages caused other than as a result of wear and tear will be charged to the group as per the attached schedule.

Liability: While all precautions are taken to ensure the safety of guests, and whilst due care will be exercised by the staff of Kerem Adventure Camp, the said staff will not incur any responsibility or liability whatsoever for any accident or illness to any guest or damage to other guest's property which may occur through any circumstance. The group agrees not to run any activities on the site without gaining authorisation from Kerem Adventure Camp's management. Children must be supervised at all times.

Payment: Payment is due in full two weeks prior to the commencement date of the camp by direct deposit. A supplementary invoice note may be issued following the camp detailing variations to the initial invoice.
