POSITION CONTEXT:

Christ Church Grammar School is an Anglican day and boarding school for boys from Pre-Kindergarten to Year 12. Located in Perth, Western Australia, the school overlooks the Swan River at Freshwater Bay in Claremont. Enrolments are comprehensive and at present are approximately 1750 students including boarders. The school consists of the Preparatory School (PK to 6) and the Senior School (Year 7 to 12).

TEACHING DUTIES:

One class of Yr 11 ATAR and one class of Yr 12 ATAR Media Production and Analysis courses, with two classes of lower school digital photography (Yr 9) and one class of visual arts (Yr 8) equivalent to 0.7 FTE for Term 2, 2024.

- Have a sound understanding of the content and structure of the ATAR Year 11 and 12 Media Production and Analysis, lower school digital photography and visual arts curriculum using contemporary learning theory and appropriate means of monitoring and assessing student achievement
- Experience with effectively reporting on curriculum outcomes
- Show an awareness of the emotional development and needs of students
- Be able to affirm and reward learning, empower and challenge students while setting high expectations
- Be able to use teaching strategies that are flexible and accommodating which cater for different ability levels
- Foster and encourage student-centered learning collaboration and peer learning through creative challenges
- An ability to model excellence in all facets of the role
