FAQs - Scholarships at Christ Church Grammar School

How much are the scholarships worth?

Our Council Scholarships for entry into Year 7 hold a value of up to 50 percent of school tuition fees. The scholarship, while subject to annual review, is tenable for the duration of a student's education at Christ Church Grammar School.

Do you offer sports scholarships?

Christ Church Grammar School does not currently offer scholarships based on sporting or other co-curricular achievements (with the exception of music and drama).

How can I prepare my son for the scholarship examination?

The scholarship examination is not one that should be studied or prepared for. The examination is set at an advanced level (Year 6) and students are encouraged to try their very best on the day. Can I see a copy of a past scholarship examination?

Unfortunately we do not provide copies of past scholarship examinations.

Can I get a copy of my child's results from the scholarship examination?

We do not distribute the exact results from the examination, however, once all the scholarships have been confirmed and awarded, we will post you a summary of your child's performance. You can expect to receive this summary around June.

How many scholarships do you award?

The number of scholarships awarded varies each year at the discretion of the Principal, however it is generally between five and eight scholarships.

What is the approximate scholarship timeline?

- Scholarship examination applications close mid-February.
- Scholarship examination takes place late-February.
- Shortlisted applicants are contacted to arrange an interview with the Principal during early April.
- Shortlisted applicant interviews will be held between the end of Term 1 and beginning of Term 2.
- Scholarship recipients are confirmed and notified by early May.
- All applicants are notified of their scholarship examination outcome by mid-May.

Do you offer scholarships for other entry years?

Council Academic, Boarding and Music scholarships at Christ Church Grammar School are only offered for entry into Year 7. We also offer regional boarding (Building Good Men) scholarships for entry into all Senior School levels and Aboriginal Scholarships for Aboriginal and Torres Strait Islander boys at various levels of entry into the Senior School. The Old Boys' Association

Scholarship Trust offers different scholarships each year, open to boys entering Year 7 (in the following year) and covering between 50% and 100% of tuition fees. Current Christ Church students and boys wishing to attend the School may apply for the Drama scholarship, open to boys entering Years 7 to 10 (in the following year).

We currently live outside of the Perth metropolitan area. Can my child still participate in the scholarship examination?

Yes, if you live interstate, overseas or in regional Western Australia, you can arrange for your child to sit the scholarship examination remotely at his current school. If this is an option you would like to pursue, you must submit a scholarship application by early February. Academic Assessment Services (AAS) will then contact your child's school and arrange for him to sit the examination. Please note that your child must sit the scholarship examination on the scheduled date, or as close as possible to this date. All examination papers will be sent directly to the School.

My child is not available to sit the scholarship examination on the scheduled date. Can they do it on another date?

No, unfortunately we are unable to facilitate an additional examination. Your child must attend the scholarship examination as scheduled if they are to be considered for a scholarship at Christ Church Grammar School.
