#### **POSITION CONTEXT:**

Christ Church Grammar School is an Anglican day and boarding school for boys from Pre-Kindergarten to Year 12. Located in Perth, Western Australia, the School overlooks the Swan River at Freshwater Bay in Claremont. Enrolments are comprehensive and at present there are approximately 1750 students including boarders.

## **DUTIES AND RESPONSIBILITIES:**

The ability to teach Health & Physical Education from Year 7 to Year 12 is essential. Previous experience teaching ATAR Physical Education Studies would be desirable.
- Teaching methodologies appropriate to mixed ability and multi-cultural student backgrounds.
- Contribute positively and collaboratively to the development of Health and Physical Education in the curriculum.
- An interest in, and commitment to, the innovative use of information and communication technologies in curriculum delivery.
- An ability to contribute to the co-curricular programs of the School.

#### **TEACHING DUTIES:**

- Health & Physical Education classes equivalent to 0.87 FTE (ongoing) or FTE 0.50 (12 months, Fixed Term 2026)
- You may in the future be required to take responsibility for a tutorial group.

## **EXPERIENCE AND QUALIFICATIONS**

## This position requires:

- Relevant tertiary teaching qualifications and experience related to the teaching of Health and Physical Education.
- All applicants must be registered to teach in Western Australia, have a National Police Clearance and have completed a Working with Children Check.

### The person must have:

- Exceptional interpersonal skills and the ability to relate to students and parents from a range of different backgrounds.
- Bronze Medallion or equivalent water safety qualification.
- Medium Rigid (MR class) heavy vehicle is essential.
- Be willing to participate in professional development as necessary.
- Be an independent worker with superior organisational skills.
- Set goals and prioritise work and the capacity to manage multiple, simultaneous tasks.
- Collaborate with others in a positive and effective manner.

New graduates with passion and relevant physical education background are welcome to apply.

### **CO-CURRICULAR:**

All Teachers are involved in some co-curricular activity commensurate and prorated according to their contract teaching load, and as a consequence, join other Teachers and possibly other members of the school community in activities which will embrace associated professional obligations e.g., collegial support and administrative meetings.

The School will consult with a Teacher with respect to the nature of their participation in the co-curricular offerings of the School. Where possible the particular skills and interests of the Teacher will be taken into consideration in the allocation of their co-curricular commitment, balanced against the School's need to adequately staff the activities on offer.
